Technology:

The system should be developed using Open Source Technology like PHP – MySQL, and is to be hosted in a compatible web hosting environment. User interface should look appealing and designed to provide hassle free user experience. The system should be light-weight to ensure fast operation by implementing CSS (bootstrap technology), and all user interactions should be implanted via jQuery / Angular JS. The agency should use highly secured and standardized PHP framework, which will operate on LINUX based web server to ensure data security of the hosted application. To ensure fast entry of existing data, the interface should provide an application for EXCEL upload of existing records.

All database queries should be optimized to ensure fast performance besides all financial transactions are to be performed in transaction mode to ensure reconciliation of Debit / Credit side.

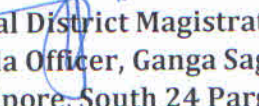
