Contractual Engagement (for 1 year) to the post of “Block Level Staff” (BLS) from the Waiting List under District Project Management Unit, Utkarsh Bangla Scheme, South 24 Parganas.

On the basis of Advertisement No. PBSSD-26/22/2020-ESTT SEC-PBSSD-Part (2) dated 14/10/2020 from PBSSD, Dept. of Technical Education, Training & Skill Development, Govt. of West Bengal, the Written Examination, Practical Examination and Interview was held on 21st November 2021, 10th February, 2022 and 26th & 27th April, 2022 respectively for the post of “Block Level Staff” and “Project Assistant cum Data Entry Operator” under District Project Management Unit, Utkarsh Bangla Scheme, South 24 Parganas.

1. A merit list cum waiting panel was published in official website of this district on 10/08/2023 vide memo no. 96/T.Ed dated 10/08/2023. Provisionally selected candidates ranked 1 to 18 in the said merit list for the post of “Block Level Staff” (vacancy: 18) and provisionally selected candidates ranked 1 to 2 in the said merit list for the post of “Project Assistant cum Data Entry Operator” (vacancy: 02) had been called for document verification in between 24/08/2023 & 25/08/2023.
2. Out of the candidates ranked 1 to 18 in the aforementioned merit list, only ten (10) candidates have joined for the post of “Block Level Staff” and out of those ranked 1 to 2, two (02) candidates have joined for the post of “Project Assistant cum Data Entry Operator”.
